Tenants or others can request a free housing inspection for habitability concerns. Re-inspection fees apply if violations are found during initial inspection and not cleared by the time follow-up inspections are performed. (Annual inspections are conducted by the property owner's designee, and "Schedule A" inspection checklists are self-enforcing.) Give copy to tenant and keep copy for your records. Business License expires Dec. 31 <sup>st</sup> and must be renewed by <b>Feb. 28<sup>th</sup></b> .  Finance Department Revenue Collection 1947 Center Street, 1 <sup>st</sup> Floor Berkeley, CA 94704	Any business that does not renew their business license by Feb. 28 (in person or postmark date) incurs late payment penalty of 10% on March 1 <sup>st</sup> ; business licenses not renewed by March 31 <sup>st</sup> incur an additional 40% penalty on April 1 <sup>st</sup> ; interest accrues on fee & penalty, at 1% per month, on any business license renewed after Feb. 28th and continues to accrue until renewed and paid in full.

<p><b>Finance Revenue Collection</b></p> <p>(510) 981-7200 (City Call Center)</p> <p><a href="mailto:BusLic@berkeleyca.gov">BusLic@berkeleyca.gov</a></p>	<p><b>New Business License</b></p> <p>\$77 per rental property + one-time \$25 registration fee + <b>\$4.00 fee</b> for State Mandated Disability Access and Education Revolving Fund.</p>	<p>Within 30 days of purchasing a property (parcel) with 3 or more dwelling units.</p> <p>Finance Department Revenue Collection 1947 Center Street, 1st Floor Berkeley, CA 94704</p>	<p>Any housing provider who owns a property with three or more rental units (or has rental units totaling 5 or more in the city) must register as a Rental Property Business (even if some or all of the units are occupied by the property owner).</p> <p>If business ownership changes, (i.e. rental property is sold) the old owner (the seller) must, within 30 days of selling, file a Closing Business License declaration and pay a business license tax based upon rents collected through the date the rental property was sold. The new property owner (the buyer) must Register/submit for a new license as a Rental Property Business.</p>
<p><b>Fire - Prevention</b></p> <p>(510) 981-5585</p>	<p><b>Annual Residential/ Business Fire Inspection Fee</b></p> <p>\$98 for every 15 minutes (or fraction thereof); Please check the Fire Department's website for the most up-to-date fee information.</p>	<p>Annual Fire Inspections occur approximately every 12 months on a recurring basis. Properties must be inspected by full-time Fire Department personnel.</p> <p>Usually billed 30-60 days after inspection; payment due <b>within 60 days of receipt of invoice.</b></p> <p>Finance Department Customer Service Center 1947 Center Street, 1<sup>st</sup> Floor Berkeley, CA 94704</p>	<p>The City inspects all properties except single-family residences and duplexes.</p> <p>The Annual Fire Inspection fee is based on the amount of time it takes to inspect the property. Additional fees apply if a re-inspection is required and non-compliance is noted.
