**FAILURE TO REFUND SECURITY DEPOSIT INTEREST
Regulation 702**

Landlords are required to return the interest earned on a tenant’s security deposit in December of each year. You may petition to collect unpaid interest. Alternatively, you may deduct accrued interest from the rent, after proper notice. (See Regulation 704.)
