<b>Notes:</b>			
A. Pursuant to Chapter 7.71 of the Berkeley Municipal Code the City of Berkeley imposes a tax on transportation network companies, commonly referred to as “ridesharing” companies a per-ride charge on all trips originating within the City of Berkeley.			
B. Delinquent date is the last day of the month following the close of the reporting period.			
C. Penalties: If tax is not remitted by the delinquent date, add a penalty of 10% of the amount of the tax.			
D. Interest: In addition to any penalties, add interest at the rate of 1% per month on the amount of the tax, from the date on which the tax first became delinquent to the date of payment.
